### **REPORT OF THE ZONAL MEETING OF ENGAGEMENT OF STATE PPMVL COMMITTEE (SOUTH-WEST GEO-POLITICAL ZONE)**

#### **1. Preamble**

The nationwide zonal engagement meeting with the State-PPMVL committees is a continuation of advocacy/sensitization activities of the phase 1 of PCN-LaunchDSI project. The meeting was organized between the PCN-LaunchDSI team and State PPMVL Committees and the officials of PPMVs associations of the six states of South-West geopolitical zone of Nigeria. The meeting was organized to harvest the views, skills, ideas and experiences on the ways and manners by which the healthcare service delivery can be improved in the patent medicines shops, and also to seek the readiness of the PPMVL committee to support the PCN towards successful implementation of the LaunchDSI project.

The meeting was attended by the Registrar, PCN, Pharm N.A.E Mohammed, members of PCN-LaunchDSI team, Directors of Pharmaceutical Services of Oyo, Ondo, Ekiti, Osun and representatives of DPS of Lagos and Ogun, Director PCN Lagos Zonal Office (LAZO), Director PCN South-West Zonal office, PCN state officers of each of the states and two officials of PPMVs association from each of the states.

#### **2. Commencement**

The meeting commenced with an opening prayer (second stanza of Nigeria's National anthem) at 10:30 am, adoption of the agenda by the DD (R&L) PCN, Pharm Yohanna A. R. and seconded by Chairman LSMUDA, Lagos. This was then followed by formal introduction by all the participants. The meeting was initially chaired by the Director Lagos Zonal office, (Pharm. A. C Ezegwu) before the registrar arrive later.

#### **3. Opening remarks**

The Registrar's opening remarks was delivered by the D. (LAZO) on behalf of the Registrar, PCN. He welcomed the participants to the meeting and thank them for honoring the invitation. The opening remarks focused on:

## **5. Commitment of support/participation by the DPSs and NAPPMED officials.**

The session was anchored by the Registrar, PCN. The enlistment of commitment of and support was made by each of the DPS and the NAPPMED official state by state. All the participants expressed their joy, commends the efforts of PCN/MSH in the repositioning strategies towards an improved PPMV operations in Nigeria and strongly pledged their commitment and buy-in towards the project's conception and implementation. All the DPSs restate their individual experiences regarding working relationship with NAPPMED and PCN state officers in their states.

## **6. Key point discussed**

- DPS Ekiti call on ensuring improvement on building trust between PCN and NAPPMED/PPMV association to ensure mutual and well-grounded relationship in order to provide a lasting foundation of the new project. He also added that in some states NAPPMED encourages proliferation of illegal PPMVs in the community through registering PCN-unregistered PMVs as their members.
- DPS Oyo state suggest that the project should be corrective in nature, and to involve more trainings.
- Representative of DPS Ogun disclosed her fears that the new “improved PPMV” may be hijacked by some bad people, thus the need for close and regular supportive supervision.
- NAPPMED Lagos and Ekiti state who is also the National Secretary NAPPMED emphasized on the mutual trust and that the new leadership of NAPPMED is ready and open for dialogue with PCN. They also call on PCN to be friendlier in approach and take them as stakeholders too.
- The issue of multiple taxation from Local Governments as another reason for non-compliance to mount PCN sign post at Patent Medicine Shop.
- NAPPMED and other splinter group should come together under one association for proper coordination, speaking with one voice and proper representations.

## **7. Closing Remarks/response by PCN**

The Registrar, PCN thanks all the participants for their words of commitment and comments and responds that:

Most of the issues raised have been addressed by the presentations and that PCN will look at individual submissions critically and come up with appropriate solutions.

NAPPMED national body should write to the PCN requesting for a courtesy visit and the PCN will give them appropriate date for the meeting.

NAPPMED should engage other splinter groups in dialogue and put her house in order so as to have one association of PPMV operators in Nigeria for proper coordination.

Plans are on-going to redesigned the PCN-Sign post and NAPPMED will be allowed to make an inputs in order to have befitting and widely accepted sign-post
