# DEVELOPMENT OF VHTs AND ADS LINKAGE STRATEGY: FOCUS GROUP DISCUSSION (FGD) GUIDE

### A. Arrival, introduction, and informed consent (20 MINUTES):

- Objective to explore ideas on how VHTs and ADS can be linked to work together to improve access to essential medicines and enhance sustainability of ADS in Kibaale district
- ii) Duration of in-depth interview  $-2\frac{1}{2}$  hours
- iii) Ask for the consent to interview explain purpose of the discussion and also explain that the information provided will be kept confidential and anonymous (s/he will not be identified as source of the information).

I will be moderating the group while my colleague will be taking notes of the proceedings of the discussion to enable us capture the key issues properly. - c) Who are the main customers of your services/business/organisation/group?
- d) How do you get the supplies/services (drugs) to your customers/clients?
- e) What are the payment arrangements for your supplies/services?
- f) Can you share with us your management arrangements in this organisation/group/business?

#### C. Proposed roles and linkages (40 MINUTES)

- a) As described in the introduction, we are proposing to develop a strategy of linking VHTs and ADS (for working together) in your community. Please share with us some of your views on this proposed linkage.
- b) What are some of the activities you see that could be harnessed to create an active linkage between ADS and VHTs in your community?
- c) What do you think are the advantages of the VHTs and ADS working together?
- d) What are the key roles you think the ADS and VHTs can play to ensure that this linkage works well?
- e) Please share with us the different ways you could support and improve the services and operations of VHTs/ADS in your community.
- f) What are some of the activities that the VHTs can engage in to ensure that this linkage is sustained?
- g) What are some of the activities that the ADS can engage in to ensure that this linkage is sustained?
- h) What are some of the opportunities you see that could be harnessed through linkage between ADS and VHTs in your community?

#### D. Motivation and operational issues (40 MINUTES)

- a) Please suggest any form of suitable incentive package that can be agreed and accepted by VHTs and the ADS for the proposed linkages.
- b) What activities should have incentives associated with them?
- c) What are some of the key standard operating procures that should be in place for the proposed linkage to work effectively?
- d) What are some of the ways to manage community perceptions about the proposed linkage and issues related to handling of medicines in the community ?
